AMENDMENT TO CERTIFICATE OF LIMITED PARTNERSHIP OF BRANDON AFFORDABLE PARTNERS, LP

Pursuant to the authority of Section 620.1202 of the Florida Revised Uniform Limited Partnership Act of 2005, the undersigned, constituting the general partner of Brandon Affordable Partners, LP, a Florida limited partnership (the "Partnership"), submits the following:

- 1. The current name of the Partnership is Brandon Affordable Partners, LP.
