**AMENDMENT TO
CERTIFICATE OF LIMITED PARTNERSHIP**

Pursuant to the authority of Section 620.1202 of the Florida Revised Uniform Limited Partnership Act of 2005, the undersigned, constituting the general partner of Vaca Bay Senior Apartments Limited Partnership, a Florida limited partnership (the "Partnership"), submits the following:

1. The current name of the Partnership is Vaca Bay Senior Apartments Limited Partnership.

2. The date of the filing of the original certificate of limited partnership of the Partnership was September 21, 2015 (the "Certificate").

3. The Certificate is hereby amended by deleting Paragraph 1 in its entirety and inserting the following in its place:


