5. The cancellation is to be effective upon the filing of the certificate.

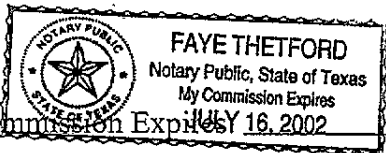

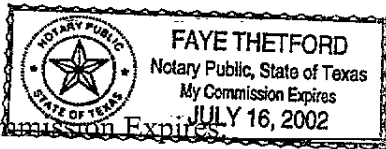
