5. The latest date upon which the limited partnership is to dissolve is December 31, 2009.

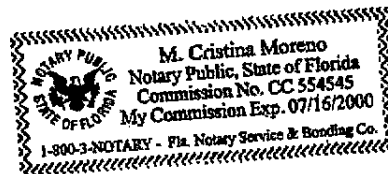
