## THIRD AMENDMENT TO AMENDED AND RESTATED CERTIFICATE AND AGREEMENT OF LIMITED PARTNERSHIP OF PALM LAKE ASSOCIATES, LTD.



Pursuant to the provisions of Section 620.109 of the Florida Revised Uniform Limited Partnership Act, The Related Companies of Florida, Inc., a Florida corporation ("RCFI"), being the current General Partner of Palm Lake Associates, Ltd., a Florida limited partnership (the "Limited Partnership"), Jorge Perez (the "Special Limited Partner"), West Palm Lake Associates Limited Partnership, a Florida limited partnership (the "Limited Partner"), and SF General, Inc., a Delaware corporation, which is withdrawing as a General Partner of the Limited Partnership, hereby execute and submit for filing with the Florida Department of Sate, this Third Amendment to Amended and Restated Certificate and Agreement of Limited Partnership to read as follows:

- 1. The name of the Limited Partnership is PALM LAKE ASSOCIATES, LTD.
- 2. The Limited Partnership was formed by the filing of a Certificate and Agreement of Limited Partnership on December 1, 1983 with the Florida Department of State. The Certificate and Agreement of Limited Partnership has subsequently been amended from time to time, and was last amended by the filing of a Second Amendment to Amended and Restated Certificate and Agreement of Limited Partnership with the Florida Department of State on March 13, 2000 (as amended, the "Partnership Agreement").
- 3. The name and address of the General Partner of the Limited Partnership from and after the date hereof are THE RELATED COMPANIES OF FLORIDA, INC., located at 2828 Coral Way, Penthouse Suite, Miami, Florida 33145. RCFI has the exclusive power and authority to act for and on behalf of the Limited Partnership in accordance with the provision of the Partnership Agreement. From and after the date hereof, RCFI shall own a 1% interest in the Limited Partnership. From and after the date hereof, SF General, Inc. shall withdraw as a General Partner of the Limited Partnership.
- 4. From and after the date hereof, the mailing address and principal place of business of the Limited Partnership shall be 2828 Coral Way, Penthouse Suite, Miami, Florida 33145.
- 5. The name and address of the Registered Agent of the Limited Partnership are Corporation Service Company, 1201 Hays Street, Tallahassee, Florida 32301.
- 6. Except as specifically amended herein, the provisions of the Partnership Except as amended, shall remain unchanged and in full force and effect.
