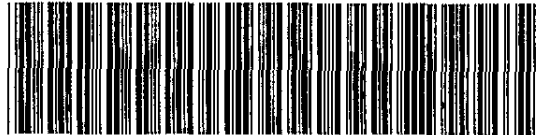

FIRST AMENDMENT TO CERTIFICATE OF LIMITED PARTNERSHIP

We, the undersigned, hereby file this First Amendment to the Certificate of Limited Partnership for Tampa I-75, Ltd.

1. The name of the limited partnership is Tampa I-75, Ltd.
2. The date of filing of the Certificate of Limited Partnership was January 5, 1984.
3. Paragraph 5 of the Certificate of Limited Partnership is amended to read in its entirety as follows:

Term. The term for which the Partnership is to exist shall be from the filing of this Certificate in the Office of the Secretary of State of Florida until January 1, 2007, unless sooner terminated as provided in the Limited Partnership Agreement.

4. One of the three General Partners, Robert S. Kerr, Jr. is deceased. The two remaining General Partners are George J. Baxter and Peter Irving. At the time of Robert S. Kerr, Jr.'s death, the written provisions of the Partnership Agreement permitted the business of the limited partnership to be carried on by the remaining General Partners, and the remaining General Partners have elected to do so.
