Term shall be amended as follows:

ARTICLE 2 - NAME, OFFICE, PURPOSE, TERM AND DISSOLUTION

Section 2.3 Term . The business of the partnership shall be activated on or before January 31, 1984 by the General Partner. The Partnership shall have a term commencing on the date the partnership is activated and continue in full force and effect until December 31, 2050, unless the Partnership shall be dissolved and its assets liquidated upon the happening of any of the following events:

- (i) The sale or other disposition of all of the assets of the Partnership, unless the Partnership receives evidences of indebtedness as a result of such sale and the General Partner determines by its sole discretion, that the Partnership shall not be dissolved until the final payment thereon or
- (ii) any event as a result of which no General Partner remains, if the Partnership is not reconstituted pursuant to Section 6.3 hereof, or
- (iii) the election to dissolve the Partnership made in writing by the General Partner with the consent of the Limited Partners.
