## AMENDMENT TO AMENDED AND RESTATED AGREEMENT AND CERTIFICATE OF BENT CREEK APARTMENTS, LTD.



Pursuant to the provisions of Section 620.1202 Florida Statutes, BENT CREEK APARTMENTS, LTD., a Florida limited partnership, having filed its original Limited Partnership Agreement on February 21, 1984, assigned Florida document number A16462, adopts the following certificate of amendment to its limited partnership agreement and certificate of limited partnership.

This amendment is submitted to amend the following sections of the Amended and Restated Agreement and Certificate filed on August 16, 1985.

- 1. Section 4 is hereby deleted in its entirety, and the following new Section 4 is hereby inserted in lieu thereof:
  - "4. <u>Term.</u> The term of the Partnership commenced on the 25<sup>th</sup> day of January, 1984, and will continue until the 31<sup>st</sup> day of December, 2043, unless sooner terminated in accordance with the Act or provisions of this Agreement."
- 2. Section 20 is hereby deleted in its entirely, and the following new Section 20 is hereby inserted in lieu thereof:
  - "20. Liquidation and Termination of the Partnership.

The Partnership shall be terminated and liquidated upon the happening of any of the following events:

- (1) upon dissolution of the Partnership if an election to continue the business of the partnership is not made;
  - (2) upon the disposition or sale by the Partnership of the Project; or
  - (3) On December 31, 2043.

Upon the termination of the Partnership, the General Partner or successors or a person elected by the Limited Partners for such purpose in the event there is then no General Partner, shall take full account of the Partnership assets and liabilities and the assets shall be liquidated as promptly as is consistent with obtaining the fair value thereof, and the Cash From Sale arising therefrom, together with assets distributed in kind, to the extent sufficient therefor, shall be applied and distributed in the manner provided in Section 26 of this Agreement."

3. Except as hereby amended, the Amended and Restated Agreement and Certificate of the Partnership is ratified and affirmed in all respects.
