Pursuant to Section 620.109 of the Florida Revised Uniform Limited Partnership Act, The Related Companies, Inc. (f/k/a August Properties Corp. I) ("August") and The Related Companies of Florida, Inc. ("RCFI"), being the General Partners of T.M. Alexander Associates, Ltd., a Florida limited partnership (the "Partnership"), SF General, Inc., a Delaware corporation ("SF General"), TMA Associates and those individuals designated as Limited Partners on Schedule "A" attached to the Partnership Agreement (as defined herein), by RCFI, as their Attorney-in-Fact, hereby execute and submit for filing with the Department of State, State of Florida, this Second Amendment to the Fifth Amended and Restated Certificate and Agreement of Limited Partnership to read as follows:

- 1. The name of the Partnership is T.M. ALEXANDER ASSOCIATES, LTD.
- 2. The Partnership was formed by the filing of a Certificate and Agreement of Limited Partnership dated February 29, 1984 and filed with the Department of State of Florida on March 5, 1984. TMA Associates shall continue to own a .99% interest in the Partnership as a Limited Partner and the individual Limited Partners shall continue to own a total of 93.11% interest in the Partnership.
