Pursuant to Chapter 620, Florida Statutes, the following is submitted in compliance with said Act:

1. That the name of the limited partnership is Orlando Transportation, Ltd.
2. That the date of filing of the agreement and certificate of limited partnership was April 11, 1984.
3. That the agreement and certificate of limited partnership shall be amended as follows effective May 14, 1997 (in accordance with 620.109(4):
 - a. having received written consent from all partners of the limited partnership, Airocar, Inc. hereby withdraws as general partner; and simultaneously
 - b. having received written consent from all partners of the limited partnership, Capital Transportation, Inc. is hereby admitted as general partner; and simultaneously
 - c. having received written consent from all partners of the limited partnership, Airocar, Inc. hereby assigns a partnership interest in the limited partnership equal to 4.9% to Capital Transportation, Inc.
 - d. having received written consent from all partners of the limited partnership, Airocar, Inc.'s remaining general partnership interest equal to 0.1% shall be a limited partnership interest.

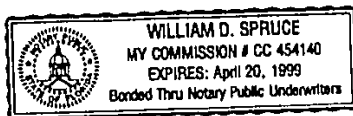
