**SECOND AMENDMENT TO  
CERTIFICATE OF LIMITED PARTNERSHIP**

Pursuant to the authority of Section 620.1202, Florida Statutes, the undersigned, constituting the sole general partner of Pierce Place Limited Partnership, a Florida limited partnership (the "Partnership"), submits the following:

1. The current name of the Partnership is Pierce Place Limited Partnership. The date of the filing of the original certificate of limited partnership of the Partnership was November 21, 2017 (the "Certificate"), Document Number A17000000564, with the name The Vistas at Fountainhead Limited Partnership. A Certificate of Amendment was filed on October 5, 2020, changing the name of the Partnership to Pierce Place Limited Partnership.

2. The Certificate is hereby amended by deleting Paragraph 1 in its entirety and inserting the following in its place:
