4. Carl Fabry maintains one (1) unit as general partner, successor to Paul and Mary Fabry, the initial general partners.



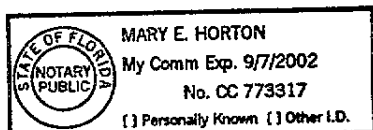
