Pursuant to the provisions of section 620.109, Florida Statutes, this Florida limited partnership, whose certificate was filed with the Florida Department of State on December 26, 1984, adopts the following certificate of amendment to its certificate of limited partnership:

**FIRST: Amendments: Article 3., strike the entire Article and insert in lieu thereof a new Article 3.:**


**In Article 5., strike the entire Article and insert in lieu thereof a new Article 5.:**
