- 1. Edward Zoller, by execution of this First Amendment, hereby acknowledges that he withdrew as General Partner of the Limited Partnership on May 12, 1998.
- 2. It is hereby confirmed that RBL Corporation, a Florida corporation is the sole General Partner of the Limited Partnership.
- 3. Except as modified herein, the Amended and Restated Certificate of Limited Partnership of RBL Associates, Ltd. is hereby affirmed as the full Agreement of the parties thereto.
