FOURTH AMENDMENT TO LIMITED PARTNERSHIP AGREEMENT

THIS FOURTH AMENDMENT TO PARTNERSHIP AGREEMENT is made and entered into as of the I day of Moreover, 2012 by and among Peter Irving and George J. The term and existence of the Partnership shall commence on the date of filing of a Certificate of Limited Partnership with the Department of State of the State of Florida and shall continue until December 31, 2015, unless the Partnership is dissolved earlier for one of the following reasons:
 - 1. the agreement in writing of all of the Partners;
 - 2. the sale or other disposition of all or substantially all of the Properties; or
 - 3. the operation of law, including without limitation, the retirement, death, insanity, liquidation or bankruptcy of a General Partner to the extent provided in Article 11.
- 2. All other terms and conditions of the Limited Partnership Agreement shall remain in full force and effect, except as modified by the terms of this Amendment
