**AMENDED AND RESTATED CERTIFICATE OF LIMITED PARTNERSHIP
FOR BOINIS ASSOCIATES, LTD.**

THIS AMENDED AND RESTATED CERTIFICATE OF LIMITED PARTNERSHIP FOR BOINIS ASSOCIATES, LTD., a Florida limited partnership (the "Amended and Restated Certificate"), is made and entered into as of the 14th day of June, 2010. The Agreement of Limited Partnership for Boinis Associates, Ltd. was originally executed on October 1, 1984, and amended on January 1, 1986, January 1, 1988, December 16, 1992, May 17, 2004, and on January 1, 2006 (collectively the "Limited Partnership Agreement").

1. **Name of Limited Partnership:** The name of the limited partnership is Boinis Associates, Ltd.

2. **Initial Certificate:** The initial certificate for Boinis Associates, Ltd. was filed with the Secretary of State for the state of Florida on October 3, 1984 (the "Initial Certificate").

3. **Changes:** This Certificate is being filed for the purpose of furnishing notice that the (i) Limited Partnership Agreement, and all amendments thereto, are no longer in effect and have been replaced and superseded by that certain Amended and Restated Partnership Agreement of Boinis Associates, Ltd. dated as of June 23, 2010 (the "Amended and Restated Partnership Agreement"); and (ii) the Initial Certificate, and all amendments thereto prior to this Amended and Restated Certificate, are hereby replaced and superseded by this Amended and Restated Certificate.

4. **Continuance Of Partnership:** Boinis Associates, Ltd. shall continue in all respects pursuant to the terms and conditions of the Amended and Restated Partnership Agreement and this Amended and Restated Certificate.


5. **Execution Pursuant to Florida Statute §620.1202:** This Amended and Restated Certificate was duly executed and is being filed in accordance with the provisions of Florida Statute §620.1202.
