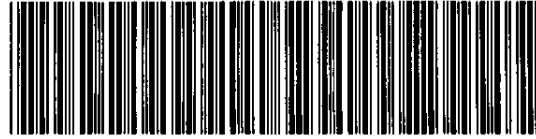

**FIRST AMENDMENT TO THE AMENDED AND RESTATED CERTIFICATE OF  
LIMITED PARTNERSHIP FOR BOINIS ASSOCIATES, LTD.**


This first amendment (the "First Amendment") to the Amended And Restated Certificate Of Limited Partnership For Boinis Associates, Ltd., a Florida limited partnership (the "Amended and Restated Certificate"), is made and entered into as of the 28th day of October, 2016. The Agreement of Limited Partnership for Boinis Associates, Ltd. was originally executed on October 1, 1984, and amended on January 1, 1986, January 1, 1988, December 16, 1992, May 17, 2004, and on January 1, 2006 (collectively the "Limited Partnership Agreement"). The Limited Partnership Agreement was subsequently amended and restated by that certain "Amended and Restated Partnership Agreement of Boinis Associates, Ltd." dated June 23, 2010 (the "Restated Partnership Agreement"). The Restated Partnership Agreement was amended on October 28, 2016, by that "First Amendment to the Amended And Restated Partnership Agreement of Boinis Associates, Ltd." (the "Partnership Agreement Amendment") (the Restated Partnership Agreement and the Partnership Agreement Amendment are referred to collectively herein as the "Amended and Restated Partnership Agreement").

1. **Name of Limited Partnership:** The name of the limited partnership is Boinis Associates, Ltd.
2. **Initial Certificate:** The initial certificate for Boinis Associates, Ltd. was filed with the Secretary of State for the state of Florida on October 3, 1984 (the "Initial Certificate").
3. **Changes:** This Certificate is being filed for the purpose of furnishing notice that the Amended and Restated Certificate, and all amendments thereto prior to this First Amendment, are hereby replaced and superseded by this First Amendment to the Amended and Restated Certificate.
4. **Continuance Of Partnership:** Boinis Associates, Ltd. shall continue in all respects pursuant to the terms and conditions of the Amended and Restated Partnership Agreement, as amended by this First Amendment to the Amended and Restated Certificate.
5. **Execution Pursuant to Florida Statute §620.1202:** This First Amendment to the Amended and Restated Certificate was duly executed and is being filed in accordance with the provisions of Florida Statute §620.1202.
6. **Effective Date:** This First Amendment shall be effective as of October 31, 2016.
