TWENTY-SIXTH AMENDMENT  
TO  
CERTIFICATE OF LIMITED PARTNERSHIP

The undersigned, desiring further to amend the Certificate of Limited Partnership of North American Company Ltd. (the "Original Certificate") pursuant to the provisions of the Uniform Limited Partnership Law of the State of Florida, and which was originally filed October 31, 1984, do certify and swear to the following:

I.

Paragraph 4 and Schedule A of the Original Certificate, as amended, are hereby further amended to read as follows:

4. The names and places of residence or business of each of the members of the Partnership and the number of General Partners' Units and Limited Partners' Units held by each, along with the names and places of residence or business of each Assignee or a Partnership Unit and the number of Partnership Units held by each as Assignee, are set forth on Schedule A hereto.

II.

Except to the extent amended by this Twenty-sixth Amendment, the Original Certificate, as previously amended, shall remain in full force and effect, and the Partners hereby ratify, readopt and confirm the terms and provisions of the Original Certificate as previously amended.

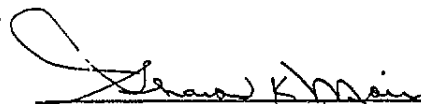
