TWENTY-FIFTH AMENDMENT
TO
CERTIFICATE OF LIMITED PARTNERSHIP
OF
NORTH AMERICAN COMPANY LTD.

The undersigned, desiring further to amend the Certificate of Limited Partnership of North American Company Ltd. (the "Original Certificate") pursuant to the provisions of the Uniform Limited Partnership Law of the State of Florida, and which was originally filed October 31, 1984, do certify and swear to the following:

I.

4. 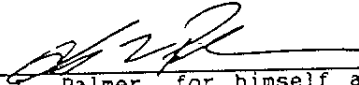
