TO
CERTIFICATE OF LIMITED PARTNERSHIP OF RPVG, LTD.**

THIS AMENDMENT AGREEMENT OF RPVG, LTD., is made and entered into, by and among the following Partners on November 24th, 2004:

Such Partners are collectively known herein as the "Partners."

RECITALS

1. The name of this Limited Partnership is "RPVG, LTD."
2. The date of filing of the Certificate of Limited Partnership for RPVG, LTD, was November 30, 1984.
3. The parties desire to expand the purpose of RPVG, LTD., so as to purchase, sell and manage expanded interests in real estate and to do so in other states.
4. The parties desire to amend the Certificate of Limited Partnership for RPVG, LTD.

NOW, THEREFORE, in consideration of the recitals described above, and the mutual benefits and obligations set forth in this Agreement, the parties agree as follows:

1. Section 5. of the original Certificate of Limited Partnership Agreement of RPVG, LTD., is hereby deleted and replaced in its entirety with the following:

“5. Purposes. The purposes of the Partnership are as follows:

(a) To purchase, sell, exchange and manage any real estate, interest in real estate and other property of all kinds, and to do such in any State or States of the United States of America.

(b) To borrow money for the foregoing purposes and to mortgage, pledge, assign, or otherwise encumber any property (or interest therein) as security for such borrowing.

(c) To enter into all contracts and other arrangements to lease the property, own, develop, operate, sell and lease portions of the property and/or improvements thereon constructed and, to do all other things necessary or desirable in connection with the foregoing.

(d) To do all things necessary or desirable in furtherance of the development of the property.

(e) To manage and operate the property together with all of the improvements and, in addition, to engage in any such other activities not prohibited by law.”

2. Subsection (i) Section 9. of the original Certificate of Limited Partnership Agreement of RPVG, LTD., is hereby deleted and replaced in its entirety with the following:

“(i) To purchase or otherwise acquire, sell, exchange, rent, hold, lease, develop, improve, maintain and trade property of all kinds, including, but not limited to, real estate, fixtures, vacant land, improved real estate, residential real estate, commercial real estate, and personal property, at such price, rental amount, lease amount, or for such terms as the General Partner deems, in his or its absolute discretion, to be in the best interest of the Partnership. Such property may be located in any State of the United States of America.”

3. This Amendment shall be effective on the date of filing with the Secretary of State of the State of Florida.

4. Except for the above Amendments, the Certificate of Limited Partnership Agreement shall remain unchanged in all other respects and shall remain in full force and effect.

The parties have executed this Agreement in North Carolina on the date first above written, as follows:
