NOW, THEREFORE, the Certificate of Limited Partnership of Riverbend Apartments, Ltd., is hereby amended as follows:


1. All references to George K. Noga as General Partner are deleted without replacement.

3. Except as amended above, the Certificate of Limited Partnership of Riverbend Apartmentst, Ltd. is hereby ratified and confirmed.



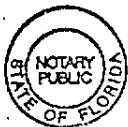
