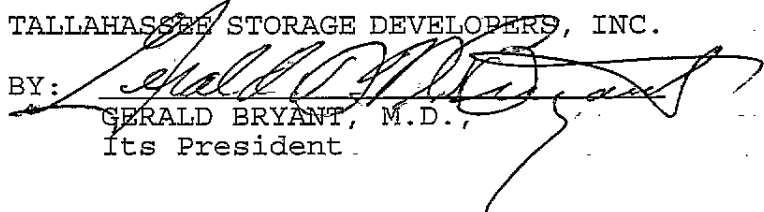

7. Additional limited partnership units may be issued pursuant to the terms and conditions of the Agreement.

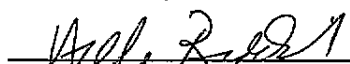
