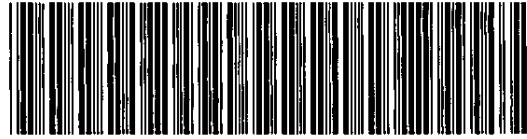





That portion of Schedule A to the foregoing document (and any amendments thereto) which lists **The Allen I. Morris Revocable Trust Dated December 13, 2004** as the holder of a 52.2093% Interest in the Partnership is hereby amended to reflect that portions of said Interest have been assigned, with the result that the following entities are now the holders of the following Interests (but are not Partners) in the Partnership:


- **The Allen I. Morris Revocable Trust Dated December 13, 2004, a 17.4031% Interest;**
