

The Amended and Restated Limited Partnership Agreement and Certificate of Limited Partnership of 1776 Associates, Ltd. (the "Partnership"), as previously amended, is hereby further amended as follows, effective as of date of filing with the Secretary of State:

That portion of Schedule A to the foregoing document (and any amendments thereto) which lists **The Allen I. Morris Revocable Trust Dated December 13, 2004** as the holder of a 17.4031% Interest in the Partnership is hereby amended to reflect that said Interest has been assigned to **The Leslie M. Feldman Living Trust Agreement Dated September 27, 2012**, with the result that the **The Allen I. Morris Revocable Trust Dated December 13, 2004** no longer owns or holds any Interest in the Partnership, and **The Leslie M. Feldman Living Trust Agreement Dated September 27, 2012** now owns and holds a 17.4031% Interest (but is not a Partner) in the Partnership.

In all other respects, the Amended and Restated Limited Partnership Agreement and Certificate of Limited Partnership of 1776 Associates, Ltd., as previously amended, shall remain in full force and effect.
