The execution of this certificate by the undersigned constitutes an affirmation under the penalties of perjury that the facts stated herein are true.

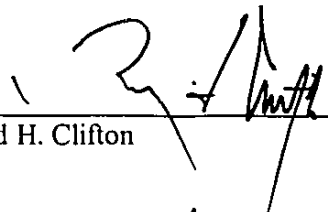

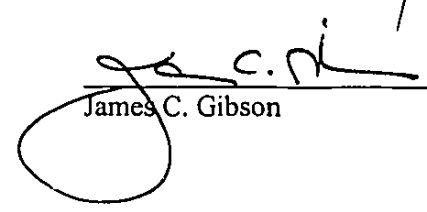
