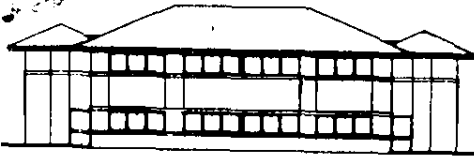


Dear Ms. Prather:
