This Certificate of Amendment to Amended and Restated Certificate of Limited Partnership and Limited Partnership Agreement of Taurus Business Center Limited, a Florida limited partnership (the "Partnership"), is executed as of the 1st day of December, 2004, by Taurus Development Two, Inc., a Florida corporation which is the sole general partner of the Partnership.

1. The Partnership's name is Taurus Business Center Limited.

2. The date of filing of the original Certificate Limited Partnership of the Partnership with the Secretary of State of Florida was September 27, 1985. Such Certificate of Limited Partnership was subsequently amended by an Amended and Restated Certificate of Limited Partnership of the Partnership filed with the Secretary of State of the State of Florida on May 4, 1987 and an Amendment thereto filed with the Secretary of State of the State of Florida on October 2, 1995.

3. Such Certificate of Limited Partnership is amended by deleting Section 1.4 thereof in its entirety and inserting in lieu thereof the following:

1.4 Purpose. The purpose and character of the business of the Partnership shall be to engage in the business of buying, owning, financing, developing, constructing, selling, operating, renovating, improving, maintaining, repairing, leasing and otherwise dealing in the development of real property consisting of approximately 5.5 acres of land and improvements thereon located in Augusta, Maine (hereinafter the "Project"), and engaging in all activities reasonably related thereto.
