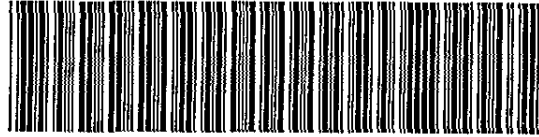


FIRST AMENDMENT TO THE LIMITED PARTNERSHIP AGREEMENT

SPANISH RIVER PLAZA, LTD.



In all other respects, the said Limited Partnership Agreement is hereby ratified and confirmed.






