THIS TWELFTH AMENDMENT OF AGREEMENT AND CERTIFICATE OF LIMITED PARTNERSHIP is made as of this 6th day of November, 2000, by TIMOTHY GRAY MALBON, Managing General Partner, on behalf of himself, MALBON MOTEL MANAGEMENT, INC., General Partner, and the parties listed in Schedule A hereto, the Limited Partners and Special Limited Partners, and is intended in accordance with Section 50-73.12 of the Code of Virginia of 1950, as amended, to amend the Agreement of Limited Partnership and the Certificate of Limited Partnership.

#### RECITALS:

- A. The name of the limited partnership is FMB Associates Limited Partnership.
- B. The date of filing of the initial Certificate of Limited Partnership was February 25, 1987, ID# L-00783.
- C. Thomas M. Malbon pursuant to certain Assignment Agreement dated November 6, 2000, has assigned one and one-third (1 1/3) Special Limited Partnership Units to Jean Malbon.
