Pursuant to the provisions of Section 620.1202, Florida Statutes, University Lithotripter, Ltd., a Florida limited partnership (the "Partnership"), whose Certificate of Limited Partnership was filed with the Florida Department of State on March 13, 1986, and assigned limited partnership number A22200, and which was amended by that certain Amended and Restated Certificate of Limited Partnership filed with the Florida Department of State on May 4, 1988, and the Second Amended and Restated Certificate of Limited Partnership filed with the Florida Department of State on April 8, 1991 (collectively, the "Certificate"), adopts the following Certificate of Amendment to the Certificate.

1. Paragraph 5 of the Certificate is amended by deleting it in its entirety and substituting the following in lieu thereof:

"The term of the Partnership shall be perpetual except as otherwise provided in the Agreement of Limited Partnership."

2. This Certificate of Amendment to the Second Amended and Restated Certificate of Limited Partnership of the Partnership shall be effective at the time of its filing with the Florida Department of State.
