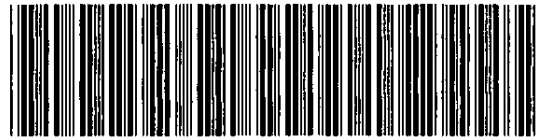


**Certificate of Dissolution

The undersigned hereby execute and adopt the following Certificate of Dissolution for Paul Family Limited Partnership, a Florida Limited Partnership, pursuant to Section 620.1203, Florida Statutes (2007), and state:


1. The name of the limited partnership is Paul Family Limited Partnership.
2. Paul Family Limited Partnership's initial certificate of limited partnership was filed with the Florida Department of State on May 28, 1986, and assigned Florida Document number A22631.
3. This Certificate of Dissolution is being filed because all of the General Partners and Limited Partners of Paul Family Limited Partnership, who also are the owners of 100% of the Partnership Capital Units, have consented to and authorized the dissolution of Paul Family Limited Partnership. The partnership's Partnership Agreement provides that the Partnership shall be terminated and dissolved upon obtaining consent "from the Limited Partners owning more than fifty percent (50%) of the Capital Units".
4. The dissolution of Paul Family Limited Partnership shall be effective upon the filing of this Certificate of Dissolution with the Florida Department of State.
