The subject limited partnership's certificate of authority was revoked April 10, 1998, for failure to file an annual report.

To reinstate the limited partnership you should file a current annual report/reinstatement, which has been signed by a general partner.

The partnership must pay filing fees totaling \$1052.50, an amount equal to the total amount it would have paid this office had it filed its annual reports in a timely manner. In addition to the filing fees, there is a fine of \$500 for each year or part thereof during which the limited partnership's certificate was revoked for the years 1984 through the present, and \$88.75 supplemental fee per year from 1992 forward. If a registered agent has not been previously designated, an additional \$35 is due to designate the registered agent.


