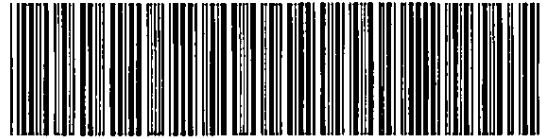

This Amendment therefore corrects, clarifies, confirms and states that the General Partner of Mowry Properties I Ltd is:




