AMENDED AND RESTATED CERTIFICATE OF LIMITED PARTNERSHIP OF 17TH STREET ASSOCIATES, LTD.

This Amendment and Restatement to Certificate of Limited Partnership is made as of this 23rd day of March, 1998 by Southport Holding Corp., a Nevada corporation authorized to transact business in Florida, as sole General Partner of 17th Street Associates, Ltd. in accordance with Florida Statutes §620.109, and the said General Partner certifies as follows:

- 1. Name of Limited Partnership. The name of the Limited Partnership is 17th Street Associates, Ltd.
- 2. <u>Date of Filing of Certificate of Limited Partnership</u>. 
