Weaver (collectively "Partners")), who collectively own One Hundred (100%) Percent of the interests in the Partnership, shall be adjusted per this Fifth Amendment as reflected in the Schedule of Capital Contribution Percentages attached to this Fifth Amendment to

the Certificate of Limited Partnership below which states the new percentage partnership interests of each of the Partners of the Partnership.

Section 2: Modification

- 2.01 Amendment. The Certificate as amended is hereby further amended by deleting the Schedule of Capital Contribution Percentages from the Fourth Amendment to the Certificate of Limited Partnership of Boywic Farms, Ltd., and substituting in its place the Schedule of Capital Contribution Percentages attached hereto which states the new percentage partnership interest of each Partner in the Partnership.
- 2.02 Certificate. Except for the modifications stated in this Fifth Amendment to the Certificate of Limited Partnership of Boywic Farms, Ltd., the terms and conditions of the Certificate as amended shall remain in full force and effect.
