FOURTH AMENDMENT TO AGREEMENT AND  
CERTIFICATE OF LIMITED PARTNERSHIP OF  
BRENTWOOD APARTMENTS PARTNERS, LTD.

Articles IV and VI of the Agreement and Certificate of Limited Partnership of BRENTWOOD APARTMENTS PARTNERS, LTD., as amended by the First Amendment to Agreement and Certificate of Limited Partnership of BRENTWOOD APARTMENTS PARTNERS, LTD., dated November 22, 1987, and filed with the Secretary of State on December 23, 1986, and a Second Amendment to Agreement and Certificate of Limited Partnership of BRENTWOOD APARTMENTS PARTNERS, LTD., dated April 1, 1988, and filed with the Secretary of State on June 21, 1988, and a Third Amendment to Agreement and Certificate of Limited Partnership of BRENTWOOD APARTMENTS PARTNERS, LTD., dated as of July 11, 1993, and filed with the Secretary of State on November 2, 1993, is amended and restated as follows:

Article IV. Name and Address of Each General and Limited Partner. BRIDY ENTERPRISES, INC., a Florida corporation, has withdrawn as General Partner of the Partnership and assigned its partnership interest to BRENTWOOD ACQUISITIONS, INC., whose address is 2350 N. E. 173 Street, North Miami, Florida 33160. P98000096708
