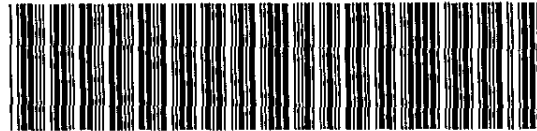

**SECOND AMENDMENT TO THE


