**CERTIFICATE OF AMENDMENT
TRANSFER AND ASSIGNMENT OF LIMITED PARTNERSHIP INTEREST
OF SHINER'S PARTNERS, LTD., a Florida limited partnership**

This Transfer and Assignment of Limited Partnership Interest (the "Assignment") executed this 30 day of July, 2004, between Dallas N. Malloy, Trustee of the Dallas N. Malloy 1997 Revocable Trust, dated October 20, 1997 ("Transferor") and the Malloy Family Limited Partnership, a Colorado limited partnership ("Transferee").

R E C I T A L S :

WHEREAS, the Transferor is a Limited Partner and owner of an undivided thirty-three (33%) percent interest in that certain Limited Partnership known as SHINER'S PARTNERS, LTD., a Florida Limited Partnership (the "Partnership"); and

NOW THEREFORE, for and in consideration of the Assignor transferring its interest to Assignee, and other valuable considerations, the receipt and sufficiency of which is hereby acknowledged, Assignor and Assignee agree as follows:

1. Recitals. The foregoing recitals are true and correct and are incorporated by reference herein.

2. Assignment. By execution of this Assignment, the Transferor hereby assigns, transfers and conveys to Transferee its undivided thirty-three (33%) percent Limited Partnership interest in and to the profits and losses of SHINER'S PARTNERS, LTD.

3. Effective Date. This Assignment shall become effective upon the date of execution hereof.

4. Miscellaneous.

A. Applicable Law. This Agreement shall be governed by and construed in accordance with the laws of the State of Florida.

B. Binding Upon Successors. Each and every provision hereof shall be binding upon and inured to the benefit of the heirs, personal representatives, successors and assigns of the respective parties hereto.






