SECOND AMENDMENT TO CERTIFICATE AND AGREEMENT OF LIMITED PARTNERSHIP SCHRIMSHER LAND FUND III, LTD.

Such amendment and substitution of general partner was in accordance with and pursuant to Sections 7.6 and 11.1(b)(iii) of the Partnership's First Amended and Restated Agreement of Limited Partnership.

- 4. Name and Business Address of the General Partner. The General Partner of the Partnership is Schrimsher, Inc., a Florida corporation, whose address is 600 East Colonial Drive, Suite 100. Orlando, Florida 32803.
- Ratification. The Certificate and Agreement of Limited Partnership will remain unchanged in all other respects and shall remain in full force and effect.
