**CERTIFICATE OF AMENDMENT  
TO THE

Pursuant to the provisions of Section 620.109, Florida Statutes, CNL Income Fund IV, Ltd., a Florida limited partnership (the "Partnership"), whose Certificate of Limited Partnership was filed with the Florida Department of State on November 18, 1987, and whose Amended and Restated Certificate of Limited Partnership (the "Certificate") was filed with the Florida Department of State on July 27, 1988, adopts the following Certificate of Amendment to its Certificate of Limited Partnership.

**FIRST:** On February 25, 2005, all interests of Ulysses Acquisition, I.L.C., a Florida limited liability company, were transferred to and assumed by Ulysses Acquisition, LLC, a Maryland limited liability company, and a substitution of the general partner occurred on that date.

**SECOND:** Article 1.17 of the Certificate shall be deleted in its entirety and replaced with the following Article 1.17.

"1.17. "General Partner" means Ulysses Acquisition, LLC, a Maryland limited liability company. The business address of the general partner is 300 East Lombard Street, Suite 1400, Baltimore, Maryland 21202."

**THIRD:** This Certificate of Amendment shall be effective at the time of its filing with the Florida Department of State.
