

Dear Mr. Bryan:

I have received your letter dated September 14, 2006 regarding the Amendment to Certificate of Authority for Foreign Limited Partnership filed for the above-referenced Limited Partnership under Fax Audit Number H06000212138 3, and I believe there is an error in this letter. Your letter requests that the Certificate of Good Standing from Virginia that accompanies the filed Amendment show the same name as the Limited Partnership. This is not possible because the Limited Partnership is merely doing business in Florida under the name "Old Dominion Limited Partnership I" because the name this entity is registered under in Virginia, Old Dominion Limited Partnership, was not available in Florida at the time the Limited Partnership was originally authorized to transact business in Florida (12/07/87). Therefore, the Certificate of Good Standing submitted to your office should suffice to prove that the Limited Partnership is in good standing in its state of domicile.

Your letter also mentions that the General Partner listed in the Amendment to Certificate of Authority for Foreign Limited Partnership filed for the Limited Partnership must be registered in the state of Florida, but your previous letters to my office did not mention that this was needed. As a result of this oversight, the filing of this Amendment for the Limited Partnership has been severely delayed. Please ensure that once the General Partner listed in this Amendment has been registered in Florida and once this Amendment has been re-sent to your office that the original date of filing (8/23/06) is given by your office for this Amendment.
