Pursuant to the Florida Revised Uniform Limited Partnership Act, The Related Companies of Florida, Inc., a Florida corporation ("RCFI"), being the sole general partner of Cutler Canal Associates, Ltd., a Florida limited partnership (the "Partnership"), AIMCO Cutler GP, L.L.C., a Delaware limited liability company and those individuals designated as Investor Limited Partner on Schedule A attached to the Partnership Agreement (as defined herein) hereby execute and submit for filing with the Department of State, State of Florida, this First Amendment to the Amended and Restated Certificate of Limited Partnership to read as follows:

1. The name of the Partnership is CUTLER CANAL ASSOCIATES, LTD.
2. The Partnership was formed by the filing of a Certificate and Agreement of Limited Partnership dated January 6, 1988 filed with the Department of State of Florida, which has subsequently been amended from time to time, and was last amended by the filing of an Amended and Restated Certificate of Limited Partnership dated April 12, 1990 filed with the Department of State of Florida (as amended, the "Partnership Certificate").

AIMCO Cutler GP, L.L.C., a Delaware limited liability company ("AIMCO Cutler") has been admitted to the Partnership as the sole general partner, having the exclusive power and authority to act for and on behalf of the Partnership in accordance with the provisions of the Partnership Agreement. From and after the date hereof, AIMCO Cutler shall own a 1% interest in the Partnership. The Investor Limited Partner shall continue to own a 99% interest in the Partnership.
