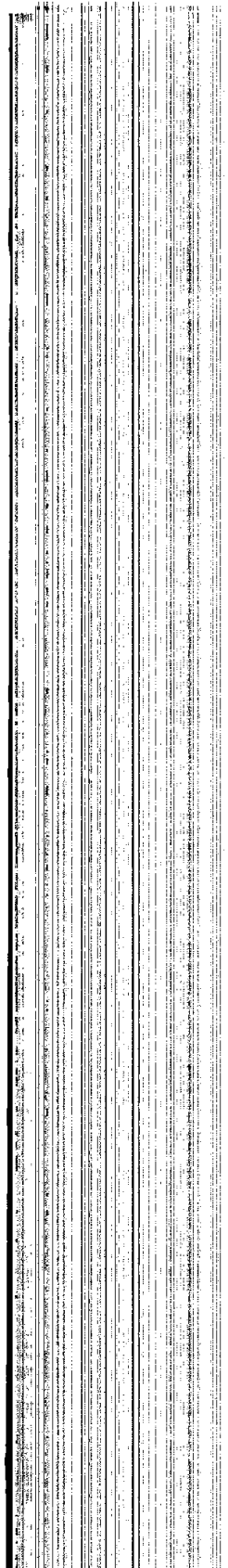

Gentlemen:

We have been advised that the above-referenced partnerships have all been revoked and that reinstatement is required. As you are aware, the penalties for such reinstatements and late filings are very excessive.

Please note that the general partner of each of these partnerships is Chateau Communities, Inc. Chateau Communities, Inc. owns and manages almost 100 properties in the state owned by various entities under its control. We have been doing business in Florida since 1985 and have always mailed our annual reports in a timely manner.

Review of the Florida state records will indicate that the annual reports for these entities were sent to a mailing address of 6430 S. Quebec St., Englewood, CO 80111. Your records will also indicate that the principal address was changed in August of 1999 to our new address of 6160 S. Syracuse Way, Greenwood, CO 80111. In that notification, the State failed to change the mailing address. Mail was forwarded from the S. Quebec St. address for approximately 12 months after which the forwarding order extension expired.

We ask that you consider this address confusion as it relates to penalties for late filings and will appreciate your positive consideration in the waiver of same.
