The fee to file the enclosed annual report is \$541.25. If a certificate of status is desired, please add an additional \$8.75. The basic annual report filing fee is figured at the rate of \$7.00 per thousand on the actual capital contributions plus a supplemental fee of \$103.75 pursuant to S. 620.193, Florida Statutes, effective 1/1/97. Therefore, the total amount due to file a limited partnership annual form on or after January 1, 1997, shall be no less than \$156.25 (\$52.50 + \$103.75) and no more than \$541.25 (\$437.50 + \$103.75).

You have indicated in block 5b or 8b on the document that the contributions of the limited partners have gone beyond what we currently have on file. A supplemental affidavit must be filed pursuant to chapter 620, Florida Statutes. The filing fee is based on the additional amount of contributions calculated at a rate of \$7 per \$1000 with a minimum filing fee of \$52.50 and a maximum filing fee of \$1750.
