THIRD AMENDMENT OF CERTIFICATE OF LIMITED PARTNERSHIP

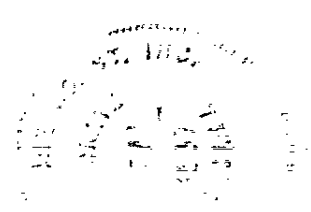
