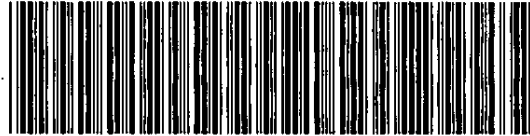

**FOURTH AMENDED  
CERTIFICATE OF LIMITED PARTNERSHIP OF  
EMERALD COAST CENTRE, LTD.**

Pursuant to the provisions of Section 620.1202 of the Florida Revised Uniform Limited Partnership Act of 2005, the undersigned, being the general partner of Emerald Coast Centre, Ltd. (the "Partnership"), does hereby adopt the following amendment thereto:

FIRST: The name of the Partnership is "Emerald Coast Centre, Ltd."

SECOND: The date of filing of its initial Certificate of Limited Partnership was September 24, 1988, which was thereafter amended by a Certificate of Amendment to Certificate of Limited Partnership, dated September 1, 1994, a Second Amended Certificate of Limited Partnership, dated July 16, 2004, and a Third Amended Certificate of Limited Partnership, dated June 1, 2005, all filed in the Office of the Florida Secretary of State.

THIRD: The Certificate of Limited Partnership is further amended to amend paragraph 6 as follows:

6. Date of Dissolution. The latest date on which the limited partnership is to dissolve is February 1, 2041.

FOURTH: In all other respects, the Certificate of Limited Partnership is herein ratified, affirmed and approved.
