Dear Mr. Kohr:

The above-named taxpayer, a client of ours, is enclosing herewith its 2004 limited partnership annual report. Also enclosed is a check made payable to the Florida Department of State for \$526.25, which represents the company's 2004 limited partnership annual report fees.

It is our understanding that for fees paid after May 1, 2004, there is a late filing fee of \$400.00. We ask that you abate this additional fee of \$400.00.

Our request for abatement is based on the following facts. In February, 2004, the taxpayer's chief financial officer of forty years retired. Because the company is an Alabama limited partnership, the new chief financial officer did not realize that a Florida annual report was due. In addition, the chief financial officer has no record of receiving either a preprinted form or a postcard in the mail from the Florida Department of State reminding the company that the annual report had to be filed. Consequently, because of the change in financial officers and because of the fact that the company is an Alabama limited partnership, and because of the fact that the new chief financial officer had no reason to believe that a Florida annual report was due, we pray that the Florida Department of State will abate the \$400.00 penalty for late payment.
