SECOND AMENDMENT TO AMENDED AND RESTATED CERTIFICATE AND AGREEMENT OF LIMITED PARTNERSHIP OF CRESCENT NURSERYFIELDS, LTD., LLLP

THIS SECOND AMENDMENT, made and entered into as of the 10 th day of June 2002, among BRYANT B. SKINNER, JR. and RUSSELL R. SKINNER (hereinafter referred to as "General Partner" or "General Partners") and BRYANT B. SKINNER, JR. and RUSSELL R. SKINNER (hereinafter sometimes referred to as "Limited Parmer," individually, and "Limited Partners," collectively).

RECITALS:

WHEREAS, the Partners formed a limited partnership under the laws of the State of Florida and entered into an Amended and Restated Certificate and Agreement of Limited Partnership as of February 13, 1998;

WHEREAS, the Partners entered into the First Amendment to the Amended and Restated Certificate of Agreement of Limited Partnership as of July 21, 2000 (the "Partnership Agreement");

WHEREAS, Paragraph 12.8 of the Partnership Agreement provides that it may be amended by a written agreement executed by all of the Partners; and

WHEREAS, the Partners wish to further amend the Partnership Agreement as hereinafter provided.

NOW, THEREFORE, in consideration of the mutual benefits to be derived herefron and other valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

The following Paragraph shall be added as a new Paragraph 7.5 to immediately followthe current Paragraph 7.4:

Transfer or Encumbrance of Real Estate. 7.5.

Any General Partner of the Partnership may convey or encumber any real property in which the Partnership has an interest and is hereby empowered to sign any other instrument affecting title to real property in which the Partnership has an interest.
