The undersigned amends the Certificate of Limited Partnership of The Floyd I. Bachrach Family Limited Partnership #1, filed December 19, 1988 in the office of the Limited Partnership Filing Section, Secretary of State, Florida, for the following reasons and in the following manner:

A majority of the voting interests of the Partners of The Floyd I. Bachrach Family Limited Partnership #1, having voted to extend the term of the Partnership for an additional twenty-five years from the date of filing of the Certificate of Limited Partnership with the Department of State, hereby amend Article II, Term of the Partnership, to read:

“ARTICLE II. TERM OF THE PARTNERSHIP. The Partnership shall commence on the date of filing of the Certificate of Limited Partnership with the Department of State and shall continue for fifty (50) years, unless sooner terminated by law or as hereinafter provided.”

All the terms and provisions of the Certificate of Limited Partnership filed December 19, 1988, as amended and filed on January 6, 1992 and December 14, 1994, except for those that are in conflict with this Amendment, shall remain as originally made.
