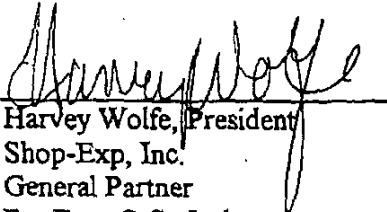
To Whom it may Concern :
